**THE BOARD OF DIRECTORS OF NORTH SONOMA COUNTY HEALTHCARE DISTRICT
NOTICE OF PUBLIC HEARING NOTICE IS HEREBY GIVEN that on Wednesday, November 18,
2020, a public hearing, as required by section 147(f) of the Internal Revenue Code of 1986, will be held by
the Board of Directors of the North Sonoma County Healthcare District (the “District”)**

With respect to the proposed issuance by the District of its North Sonoma County Healthcare District Refunding Revenue Bonds, Series 2020, in an amount not to exceed \$10,850,000 (the “Bonds”). The proceeds of the Bonds will be used (a) to provide for the defeasance and redemption of the outstanding North Sonoma County Healthcare District Certificates of Participation (2016 Financing Project) (the “2016 COPs”), and (b) to pay for costs of issuance of the Bonds. The 2016 COPs were delivered to refund prior certificates of participation delivered in 2008 to finance capital projects at the District’s hospital located at 1375 University Avenue in Healdsburg, California (the “Hospital”). The Hospital is located entirely within the territorial limits of the District, is currently owned by the District. It is expected that the Hospital will be sold in 2021 to, and thereafter owned and operated by NorCal HealthConnect, LLC, a California limited liability company (“NorCal”).

Western HealthConnect, LLC, a Washington limited liability company, is the sole member of NorCal (“Western”). Western is a secular affiliate of Providence St. Joseph’s Health, a 501(c)(3) nonprofit corporation. The District’s obligation to pay the principal of and interest on the Bonds will be secured by a pledge of, and a first and prior lien on, the revenues derived by the District from a special parcel tax approved by the qualified voters of the District on April 13, 2004 (the “Parcel Tax”) and will not constitute an obligation of the District for which the District is obligated to levy or pledge any form of taxation or for which the District has levied or pledged any form of taxation, other than the Parcel Tax. The hearing will commence at 5:30 P.M. or as soon thereafter as the matter can be heard.
